1. INTERNAL AUDIT – TERMS OF REFERENCE

RECOMMENDED

THAT the Terms of Reference for Internal Audit be reviewed.

2. PURPOSE OF REPORT.

- 2.1 To ask the Committee to review the Terms of Reference for Internal Audit.

3. BACKGROUND

- 3.1 The CIPFA Code of Practice for Internal Audit in Local Government in the United Kingdom 2006 states that the purpose, authority and responsibility of Internal Audit must be formally defined by the organisation in terms of reference consistent with the code.
- 3.2 The terms of reference have been prepared in line with the example given in the CIPFA Code of Practice for Internal Audit in Local Government in the United Kingdom 2006. They were approved by the Audit and Performance Management Committee at their first meeting on 28 January 2008. It is recommended good practice that they are subject to annual review. They have since been reviewed at the Committee's January meeting each year. There have been no changes to the terms of reference since the 2012 review.

4. EQUALITY IMPACT ASSESSMENT

In preparing this report an initial Equality Impact Assessment is not required and has not been carried out. The matters contained in this report will not lead to and/or do not relate to a policy change.

5. **LEGAL IMPLICATIONS**
