#### 1. <u>HEALTH AND SAFETY PERFORMANCE</u>

Report of the Chief Fire Officer.

## 2. **PURPOSE OF REPORT**

This report is submitted to inform the Authority of the health and safety performance of the Brigade for the year April 2005 – March 2006.

#### 3. **BACKGROUND**

- 3.1 Over the last 15 years the Brigade has dramatically reduced the number of workplace injuries, culminating in the best ever year for accident prevention.
- 3.2 The total number of injuries has fallen by 55% in the last 15 years.

3.3 The more serious injuries (those reportable to the Health and Safety Executive under the Reporting of Injuries, Diseases and Dangerous Occurrences Regulations (RIDDOR) have fallen by 78%.

These include two dislocations, the rest were over 3 day absence injuries.

There were no fatalities in 2005/06.

- 3.4 The lowest number of injuries ever recorded was for last year (2005/2006). A graph showing the progress over the last 15 years can be seen in Appendix 1. The reduction far exceeds the Government's Revitalising Health and Safety Targets set in 1999/2000 (a 10% reduction in major injuries by 2010).
- 3.5 The knock on effect of this, is that there were fewer days lost (sickness) due to injury. There was a 25% reduction in days lost through injury compared to the previous year (2004/2005). Last year only 1707 days (approximately) were lost through injury.
- 3.6 For the first time ever, the number of near hits (427) exceeded the number of injuries (370). This is the correct proactive trend. A near hit is something that almost resulted in an injury. It is an unsafe act or condition.
- 3.7 Last year, the Health and Safety Team analysed injuries for trends and then targeted their work to help reduce injury potential. This involved supporting Stations/Departments that reported a large number of injuries. The team carried out 11 health and safety audits of Stations and Departments. Manual handling injuries, slips and trips and injuries from dismounting the fire appliance were all investigated further and campaigns carried out.

#### 4. **EQUALITY IMPACT ASSESSMENT**

In preparing this report an initial Equality Impact Assessment was carried out. The initial Equality Impact Assessment did not raise issues which required a full Equality Impact Assessment to be completed.

#### 5. **LEGAL IMPLICATIONS**

The course of action recommended in this report does not raise issues which should be drawn to the attention of the Authority's Monitoring Officer.
