1. REVIEW OF CHARGES – FIRE CERTIFICATES, PETROLEUM SEARCHES AND SPECIAL SERVICE CHARGES

Joint report of the Chief Fire Officer and the Treasurer.

RECOMMENDED

THAT the Authority approve the revised charges with effect from 1st April 2007 for Fire Certificates, Petroleum Premises File Searches and for Special Service Charges.

2. **PURPOSE OF THE REPORT**

This report is submitted to seek the Authority's approval for revised charges for Fire Certificates, Petroleum Premises File Searches and for Special Service Charges.

3. **BACKGROUND**

The current level of charges was agreed at the February 2006 Authority Meeting.

3.1 Fire Certificates

The proposed charges have been adjusted to reflect the recommended level of charges as per the LGA Circular 112/06 and estimated firefighters' pay awards for July 2007, and are shown in Appendix I.

3.2 <u>Duplicate Fire Certificates</u>

The charges have been revised to reflect the anticipated inflation affecting the Authority up to March 2008. It is therefore proposed that the charges should be increased from £31.00 to £32.00 per certificate, with the additional charge of £1 for each additional plan of a multiple plan certificate unchanged.

3.3 Petroleum Premises File Searches

Taking into account anticipated inflation up to March 2008, it is proposed that the charge should be increased from £38 to £39 per application.

3.4 Duplicate Petroleum Licences

Taking into account anticipated inflation up to March 2008, it is proposed that the charge should be increased from £23.00 to £24.00 per Duplicate Petroleum Licence.

3.5 Special Service Charges

The proposed charges have been increased predominantly to reflect the anticipated firefighters' pay awards from July 2007 and are shown in Appendix I.

4. **EQUALITY AND DIVERSITY IMPLICATIONS**

In preparing this report an initial Equality Impact Assessment is not required and has not been carried out as the matters contained in this report will not lead to and do not relate to a policy change.
