5/09 **Employee Assistance Service Update**

The Panel received an update on the work of the Employee Assistance Service. The service complemented the existing Occupational Health and Well Being Service and provided confidential support, by various means, to employees and their immediate family members with personal or work related problems which were likely to affect their performance in the workplace.

The service was currently provided by Validium, an external organisation, however the contract was due to end on 30th November 2009.

Usage of the service currently stood at around 10% annually. Feedback from employees using the service had been excellent; however, disappointingly, there was still a lack of awareness amongst employees and some managers. Consequently, further work was being done to promote the service including manager briefings and mail shots circulated with payslips.

It was noted that Corporate Board had given approval to extend the contract for a further year until 30th November 2010 in order to assess the benefits of the service to employees and the organisation.
