1. **APPOINTMENT OF REPRESENTATIVES TO SERVE ON OTHER BODIES**

Report of the Clerk

RECOMMENDED that the Authority nominates representatives to serve on the bodies referred to in this report.

2. **PURPOSE**

The purpose of the report is to request the Authority to appoint representatives to serve on other bodies during 2010/2011.

3. **REPORT DETAILS**

3.1. The Authority is requested to appoint representatives to serve on other bodies. The following is a list of organisations to which appointments were made in 2009/2010 together with details of the members appointed for that year. An asterisk against the title of the body indicates that proportionality applies.

- **West Midlands Regional Management Board***
(3 representatives)

Chairman of the Authority (Councillor Ward)
Councillor Hinton
Councillor Eustace

The Authority is allowed to send substitute members if the appointed member is unable to attend.

- **Local Government Association General Assembly***
(4 representatives)

Chairman of the Authority (Councillor Ward)
Vice Chairman of the Authority (Councillor S Davis)
Councillor Hinton
Councillor Eustace (*or their nominees*)

The Association encourages Authorities entitled to three or four representatives on the General Assembly to allocate one of those positions to Minority Group Leaders on their Authorities.

In 2009/2010, the Chairman (or his nominee) was authorised to exercise the Authority's corporate vote at the General Assembly. The Authority has five votes overall and these are allocated amongst members according to proportionality. In 2010/11 the votes will be allocated as follows:

Conservative 2, Labour 2, Liberal Democrat 1

(Note: only elected members may vote at meetings. Authorities may appoint two elected members or one member and one officer.)

- **West Midlands Local Government Association Association - Observer Member**

Chairman of the Authority (Substitute –Vice Chairman).

Provincial Council

Councillor Gazey (substitute tba).

- **Black Country Consortium** (1 observer member)

It is recommended that the appointed Member should be from one of the four Black Country boroughs.
