Councillors Edwards and O'Neill declared non-disclosable pecuniary interests in Minute No 104/12 below (Monitoring of Finances).

101/12 **Chair's and Chief Fire Officer's Announcements**

The Chair welcomed Mr Bell, Mr Clothier and Mrs Tyler who were attending as observers at their first Authority meeting. He reminded members that the Authority had agreed to appoint these persons as independent persons in connection with standards matters.

The Chief Fire Officer reported that the Service was currently dealing with a serious fire in Langley at premises where alcohol was stored in tanks. 15 pumps were in attendance. High volume pumps had also been sent to Gloucestershire as flooding was anticipated.

The Chief Fire Officer also reported that two teams from the service had been competing in a national breathing apparatus competition. The team from Sheldon Fire Station had won the competition. The Chief Fire Officer indicated that the team were a credit to the organisation and that their success was the result of years of training,

Mr Walton had been born at the old Fire Service Headquarters and had entered the Service himself in 1985 at the age of 18. He had worked in various capacities over his 27 years with the Service and was now Acting Assistant Chief Fire Officer. The Chair presented Mr Walton with a framed photograph of the old and new Headquarters buildings. Members thanked Mr Walton for his service and wished him success in his new post.
