## 23/08 Chief Fire Officer's Introduction

The Chief Fire Officer welcomed Members of the Fire Authority and informed them that the transfer of the Brigade's fire control to the new Headquarters building had gone smoothly, including the upgrading of the response system. He explained that the system had improved capability to despatch and track machines and would provide an improved and more resilient service. A Member visit to fire control would be arranged shortly.

He reported that a major incident had recently occurred in Bilston, and fifteen pumps had been used to tackle the difficult fire, which had started in the roof of a copper manufacturer.

#### 24/08 Sedgley Fire Station – Outcome of Consultation Proposals

Members received an update on the outcome of the public

consultation regarding the provision of fire cover from Sedgley fire station. It was reported that a large quantity of petitions, and also

Members were reminded that the proposals were based on operational risk analysis and that other fire stations in the area were able to provide a quicker response in the event of an incident. Members discussed the points raised by the consultees and the proposed responses of the Authority.
